

**CITY OF WOODLAWN PARK
ORDINANCE NO. 3, SERIES 2022-2023**

**AN ORDINANCE APPROVING THE USE OF AMERICAN RESCUE PLAN
ACT FUNDS FOR ROAD MAINTENANCE**

WHEREAS, the City of Woodlawn Park is authorized and empowered to enact ordinances not in conflict with the Constitutions or laws of the United States and this Commonwealth, and

WHEREAS, the United States Congress passed the American Rescue Plan Act ("ARPA"), enacted on March 11, 2021, which law provides individual local governments an allotment of funds for a variety of purposes related to the COVID-19 virus, and

WHEREAS, cities with ARPA allocations of less than \$10,000,000.00 may elect to use their allocations for a broad range of general government purposes and the City of Woodlawn Park hereby elects to do so, and

WHEREAS, the sum of \$112,100.00 has been allocated to the City of Woodlawn Park pursuant to ARPA, and

WHEREAS, the City of Woodlawn Park desires to use its ARPA State and Local Fiscal Recovery Funds ("SLFRF") for road maintenance ("the Project") and to increase the annual salary of the Chief of Police ("the Police Salary Increase Project") and to authorize the Mayor to execute any and all documents deemed necessary for participation in the ARPA SLFRF Program,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF WOODLAWN PARK, KENTUCKY AS FOLLOWS:

Section 1. The City of Woodlawn Park hereby elects to treat the entirety of its ARPA allocation to replace lost public sector revenue inasmuch as its allocation is less than \$10,000,000.00 and the expenditure is not prohibited under the ARPA Final Rule issued by the U.S. Treasury Department on January 6, 2022. Further, the City of Woodlawn Park elects to use the standard allowance of up to \$10,000,000.00, not to exceed the City's actual allocation, with an effective date of January 31, 2022.

Section 2. The City of Woodlawn Park hereby authorizes the Mayor to execute any and all agreements necessary to implement the Project utilizing ARPA SLFRF funding, in whole or in part, and to execute any documents deemed necessary by the U.S. Treasury Department in order to participate in the ARPA SLFRF Program and to have full authority to serve as the authorized correspondent for the Project.

Section 3. The City of Woodlawn Park hereby authorizes an expenditure of ARPA SLFRF funds in the amount of \$101,878.75 for milling and paving of Ahland Road, Ambridge Circle, Beechwood Road, Green Meadow Court, Perryman Road, Walser Road and Westport Terrace East.

Section 4. The Project shall be referred to as Project Number 2, Series 2022, City of Woodlawn Park Repaving Project.

Section 5. The City of Woodlawn Park hereby authorizes an expenditure of ARPA SLFRF funds in the amount of \$3,000.00 for an increase in the annual salary of the Chief of Police, Michael Koenig, commencing on September 1, 2022.

Section 6. The Police Salary Increase Project shall be referred to as Project Number 3, Series 2022, City of Woodlawn Park Police Salary Increase Project.

Section 7. Ordinance shall take effect upon its passage and publication.

First Reading held July 18, 2022.

Second Reading, Passed and Approved August 15, 2022.
